SUMMARY ORDER

(Pursuant to K.S.A. 2002 Supp. 40-4909 and K.S.A. 77-537)

Pursuant to authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 2002 Supp. 40-4909, the Commissioner hereby revokes the nonresident agent's license of Raymond Anthony Vanderfliet, Sr. ("Vanderfliet") by way of Summary Order as provided by K.S.A. 77-537.

Findings of Fact

The Commissioner has been shown the following facts:

- 1. Records maintained by the Kansas Insurance Department ("KID") indicate that Vanderfliet is licensed as a nonresident agent to transact the business of insurance in the State of Kansas. KID records further indicate a legal and mailing address of 86 Patchogue Dr., Rocky Point, NY 11778.
- 2. The National Association of Insurance Commissioners ("NAIC") Regulatory Information Retrieval System ("RIRS") database reflects the following information: The State of New York revoked Vanderfliet's resident insurance agent's license, effective February 24, 2003, because of "demonstrated lack of fitness or trustworthiness. Previously, the State of Maine had revoked Vanderfliet's license, effective March 1, 2001, for "failure to pay 1st time license fee."

- 3. The New York revocation order states that Vanderfliet denied on his renewal application that he had had an existing license revoked since his last application, notwithstanding the intervening revocation in Maine, and that Vanderfliet did not cooperate with the New York Insurance Department's investigation and failed to appear for hearing.
 - 4. To date, neither of these actions has been reported to the KID.

Applicable Law

5. K.S.A. 2002 Supp. 40-4909(a) provides, in relevant part:

"The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has . . . (2) Violated: (A) Any provision of chapter 40 of the Kansas Statutes Annotated, and amendments thereto, or any rule and regulation promulgated thereunder; . . . (9) Had an insurance agent license, or its equivalent, denied, suspended or revoked in any other state, district or territory." K.S.A. 2002 Supp. 40-4909(a).

- 6. Administrative regulations require that a person licensed in this state as an insurance agent shall, within 30 days of the occurrence, report enumerated events to the Commissioner. Among these events are disciplinary action against the agent's license by the insurance regulatory official of any other state or territory. K.A.R. § 40-7-9.
- 7. K.S.A. 2002 Supp. 40-4906 and 4908 provide for issuance of a nonresident agent's license in reliance upon the agent's valid license in the agent's home state.
- 8. The Commissioner may revoke any license issued under the Insurance Agents Licensing Act if the Commissioner finds that the insurable interests of the public are not properly served under such license. K.S.A. 2002 Supp. 40-4909(b).

Conclusions of Law

- 9. The Commissioner has jurisdiction over Vanderfliet as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 10. The Commissioner finds that Vanderfliet's Kansas license may be revoked solely because Vanderfliet has had a license revoked in another state.
- 11. The Commissioner further finds that Vanderfliet's Kansas nonresident insurance agent's license is based on reciprocity with the State of New York and issued in reliance upon New York licensing standards.
- 12. The Commissioner concludes that Vanderfliet is no longer entitled to hold a license based on reciprocity because the New York license has been revoked.
- 13. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of Raymond Anthony Vanderfliet, Sr., pursuant to K.S.A. 2002 Supp. 40-4909(a).
- 14. Moreover, the Commissioner finds that Vanderfliet's insurance agent's license should be revoked pursuant to K.S.A. 2002 Supp. 40-4909(b) for the protection of the insurable interests of the public.
- 15. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the KID to give notice and opportunity to participate to persons other than Raymond Anthony Vanderfliet, Sr.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE

THAT the Kansas resident insurance agent's license of Raymond Anthony Vanderfliet, Sr., is hereby **REVOKED**.

Notice and Opportunity for Hearing

Raymond Anthony Vanderfliet, Sr., within fifteen (15) days of service of this Summary Order, may file with the KID written request for a hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to John W. Campbell, General Counsel, Kansas Insurance Department, 420 S.W. 9th Street, Topeka, KS 66612.


Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with the reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this summary order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen-day period for requesting a hearing.

The Final Order will constitute final agency action in this matter.
