SUMMARY ORDER

(Pursuant to K.S.A. 2002 Supp. 40-4909 and K.S.A. 77-537)

Pursuant to authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 2003 Supp. 40-4909, the Commissioner hereby revokes the nonresident agent's license of Thomas E. Hassell ("Hassell") by way of Summary Order as provided by K.S.A. 77-537.

Findings of Fact

The Commissioner has been shown the following facts:

1. Records maintained by the Kansas Insurance Department ("KID") indicate that Hassell is licensed as a nonresident agent to transact the business of insurance in the State of Kansas, and has been so licensed since April 23, 2001. KID records further indicate a legal and mailing address of 16776 Peace Valley Lane, Ramona, CA 92065.
2. Hassell's California resident insurance agent's license was revoked by Default Decision and Order of Revocation dated March 1, 2004.
3. To date, Hassell has not notified KID of the action.

Applicable Law

4. K.S.A. 2003 Supp. 40-4909(a) provides, in relevant part:

"The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has . . . (9) Had an insurance agent license, or its equivalent, denied, suspended or revoked in any other state, district or territory. . . ." K.S.A. 2003 Supp. 40-4909(a).

5. Administrative regulations require that a person licensed in this state as an insurance agent shall, within 30 days of the occurrence, report enumerated events to the Commissioner. Among these events is disciplinary action against the agent's license by the insurance regulatory official of any other state or territory. K.A.R. § 40-7-9.

6. K.S.A. 2003 Supp. 40-4906 and 4908 provide for issuance of a nonresident agent's license in reliance upon the agent's valid license in the agent's home state.

7. The Commissioner may revoke any license issued under the Insurance Agents Licensing Act if the Commissioner finds that the insurable interests of the public are not properly served under such license. K.S.A. 2003 Supp. 40-4909(b).

Conclusions of Law

8. The Commissioner has jurisdiction over Hassell as well as the subject matter of this proceeding, and such proceeding is held in the public interest.

9. The Commissioner finds that Hassell's Kansas license may be revoked solely because Ellis has had an agent's license revoked in another state.

10. The Commissioner finds, in addition, that Hassell's Kansas license may be revoked because it is based on reciprocity, and Hassell's license in his home state of California has been revoked.

11. The Commissioner also finds that Hassell's license may be revoked because Hassell has violated the regulation requiring an agent to report a disciplinary action taken by another regulatory authority against a professional license.


12. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of Thomas E. Hassell pursuant to K.S.A. 2003 Supp. 40-4909(a).

13. In addition, the Commissioner finds that the insurance agent's license of Thomas E. Hassell should be revoked without delay for the protection of the insurable interests of the public pursuant to K.S.A. 2003 Supp. 40-4909(b).

14. Based on the facts and circumstances set forth herein, it appears that the use of summary proceedings in this matter is appropriate, in accordance with the provisions set forth in K.S.A. 77-537(a), in that the use of summary proceedings does not violate any provision of the law and the protection of the public interest does not require the KID to give notice and opportunity to participate to persons other than Thomas E. Hassell.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT the Kansas nonresident insurance agent's license of Thomas E. Hassell is hereby REVOKED.

NOTICE OF SUMMARY ORDER
