#### **SUMMARY ORDER**

(Pursuant to K.S.A. 40-4909, K.S.A. 77-501)

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby revokes the agent's license of Respondent, **ROBBIE K. TAYLOR** ("Respondent"). This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

#### **Findings of Fact**

The Commissioner finds the following facts:

- 1. Respondent was licensed as a Kansas nonresident insurance agent on May 3, 2018, and remains licensed to date.
- 2. Respondent's legal (residential) address of record is 8751 Rosebud Pl., Parker, CO 80134.
- 3. On August 1, 2018, the Kansas Insurance Department ("KID") received a notice of termination for cause for Respondent from The Chesapeake Life Insurance Company ("Chesapeake"). The notice advised Respondent was terminated due to suspected fraud.
- 4. Specifically, Chesapeake's investigation found:
  - a. Respondent submitted fifty-nine (59) insurance applications between January 2015 and May 2018 where the initial premium payments failed.
  - b. Each of those applications had applicants that were unable to be verified as existing by the applicant's name, date of birth, Social Security number, and address or state.
- 5. KID sent a letter to Respondent on November 19, 2018 listing the allegations and requesting a response. Respondent did not reply.

#### Applicable Law

- Pursuant to K.S.A. 40-4909(a), "The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
  - o (5) Intentionally misrepresented the provisions, terms and conditions of an actual or proposed insurance contract or application for insurance.
  - o (8) Used any fraudulent, coercive, or dishonest practice, or demonstrated any incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere." K.S.A. 40-4909(a)

#### **Policy Reasons**

- 1. It is in the public interest that the license of an agent who intentionally misrepresented the provisions, terms and conditions of an actual or proposed insurance contract or application for insurance be revoked.
- 2. It is in the public interest that the license of an agent who has used any fraudulent, coercive, or dishonest practice, or demonstrated any incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere be revoked.

#### **Conclusions of Law**

- 1. The Commissioner has jurisdiction over **ROBBIE K. TAYLOR** as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 2. The Commissioner finds that Respondent's Kansas license may be revoked because **ROBBIE K. TAYLOR** intentionally misrepresented the provisions, terms and conditions of an actual or proposed insurance contract or application.
- 3. The Commissioner finds that Respondent's Kansas license may be revoked because **ROBBIE K. TAYLOR** has used any fraudulent, coercive, or dishonest practice, or demonstrated any incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere.
- 4. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent's license.
- 5. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of **ROBBIE K. TAYLOR**, pursuant to K.S.A. 40-4909(a) and (b).

# IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

- 1. The Kansas Nonresident Insurance Agent's License of **ROBBIE K. TAYLOR** is hereby **REVOKED** the effective date of this Order.
- 2. **IT IS FURTHER ORDERED** that **ROBBIE K. TAYLOR** shall **CEASE** and **DESIST** from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

**ROBBIE K. TAYLOR**, within fifteen (15) days of service of this Summary Order, may file with the Kansas Insurance Department a written request for hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to:

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
