<u>SUMMARY ORDER</u> (Pursuant to K.S.A. 40-4909, K.S.A. 77-501)	
Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner K.S.A. 40-4909, the Commissioner hereby revokes the agent's license of Respondent, <b>LAYN WHEAT</b> ("Respondent"). This Summary Order shall become effective as a Final Order, with further notice, upon the expiration of the fifteen (15) day period if no request for hearing is no pursuant to K.S.A. 77-542.	(E C.
Findings of Fact	
The Commissioner finds the following facts:

# Applicable Law

- Pursuant to K.S.A. 40-4909(a), "The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
  - o (1) Provided incorrect, misleading, incomplete or untrue information in the license application.
  - o (3) Obtained or attempted to obtain a license under this act through misrepresentation or fraud. ...[and/or]
  - o (6) Been convicted of a misdemeanor or felony." K.S.A. 40-4909(a)

### **Policy Reasons**

- 1. It is in the public interest that the license of an agent who provided incorrect, misleading, incomplete or untrue information in the license application be revoked.
- 2. It is in the public interest that the license of an agent who obtained or attempted to obtain a license under the agent licensing act through misrepresentation or fraud be revoked.
- 3. It is in the public interest that the license of an agent who has recently been convicted of a military offense be revoked.

## Conclusions of Law

- 1. The Commissioner has jurisdiction over LAYNE C. WHEAT as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- The Commissioner finds that Respondent's Kansas license may be revoked because LAYNE C. WHEAT provided incorrect, misleading, incomplete or untrue information in the license application.
- 3. The Commissioner finds that Respondent's Kansas license may be revoked because LAYNE C. WHEAT obtained a license through misrepresentation.
- 4. The Commissioner finds that Respondent's Kansas license may be revoked because LAYNE C. WHEAT was recently convicted of a military offense.
- 5. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent's license.
- 6. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of LAYNE C. WHEAT, pursuant to K.S.A. 40-4909(a) and (b).

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

- 1. The Kansas nonresident Insurance Agent's License of LAYNE C. WHEAT is hereby **REVOKED** the effective date of this Order.
- 2. IT IS FURTHER ORDERED that LAYNE C. WHEAT shall CEASE and DESIST from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

#### NOTICE AND OPPORTUNITY FOR HEARING

**LAYNE C. WHEAT**, within fifteen (15) days of service of this Summary Order, may file with the Kansas Insurance Department a written request for hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to:

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
