

SUMMARY ORDER
(Pursuant to K.S.A. 40-4909, K.S.A. 77-501)

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby revokes the agent's license of Respondent, **LAYNE C. WHEAT** ("Respondent"). This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

Findings of Fact

The Commissioner finds the following facts:

1. Respondent was licensed as a Kansas resident insurance agent on August 4, 2018, and remains licensed to date.
2. Respondent's legal (residential) address of record is 13131 S Summit St, Olathe KS 66062-8804 and mailing address of record is 120 W 12th St., STE 1700, Kansas City MO 64105-1923.
3. On July 12, 2018, Respondent submitted an application for a Kansas resident individual insurance agent license ("Application").
4. The application appeared to be submitted by an authorized submitter, Evan Harris with Spring Insurance Solutions. An applicant is ultimately responsible for the information found on the application.
5. Background Question 1c under Item 38 of the application asks, "Have you ever been convicted of a military offense, had a judgment withheld or deferred, or are you currently charged with committing a military offense?"
6. Respondent answered "No."
7. 
8. On August 4, 2018, a resident agent license was granted to Respondent by the Commissioner. The application would not have been granted but for the omission of the military conviction.
9. Mr. Harris notified KID on August 8, 2018 that Respondent failed to provide the information to Mr. Harris when Mr. Harris was filling out the application on his behalf. Mr. Harris submitted documentation for the 2016 UCMJ violation as well as information on a new violation of disorderly conduct in Kansas City Municipal Court that is currently pending and has a court date of September 25, 2018 (Ticket #2G140428).

10. Respondent provided an explanation letter for the military offense and said he did not previously disclose it because he was unaware of anything being on his record. However, Respondent acknowledged his convictions when signing his fingerprint waiver on July 12, 2018.

Applicable Law

- Pursuant to K.S.A. 40-4909(a), “The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
 - (1) Provided incorrect, misleading, incomplete or untrue information in the license application.
 - (3) Obtained or attempted to obtain a license under this act through misrepresentation or fraud. ...[and/or]
 - (6) Been convicted of a misdemeanor or felony.” K.S.A. 40-4909(a)

Policy Reasons

1. It is in the public interest that the license of an agent who provided incorrect, misleading, incomplete or untrue information in the license application be revoked.
2. It is in the public interest that the license of an agent who obtained or attempted to obtain a license under the agent licensing act through misrepresentation or fraud be revoked.
3. It is in the public interest that the license of an agent who has recently been convicted of a military offense be revoked.

Conclusions of Law

1. The Commissioner has jurisdiction over **LAYNE C. WHEAT** as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
2. The Commissioner finds that Respondent’s Kansas license may be revoked because **LAYNE C. WHEAT** provided incorrect, misleading, incomplete or untrue information in the license application.
3. The Commissioner finds that Respondent’s Kansas license may be revoked because **LAYNE C. WHEAT** obtained a license through misrepresentation.
4. The Commissioner finds that Respondent’s Kansas license may be revoked because **LAYNE C. WHEAT** was recently convicted of a military offense.
5. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent’s license.
6. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent’s license of **LAYNE C. WHEAT**, pursuant to K.S.A. 40-4909(a) and (b).

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

1. The Kansas nonresident Insurance Agent's License of **LAYNE C. WHEAT** is hereby **REVOKED** the effective date of this Order.
2. **IT IS FURTHER ORDERED** that **LAYNE C. WHEAT** shall **CEASE** and **DESIST** from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

NOTICE AND OPPORTUNITY FOR HEARING

LAYNE C. WHEAT, within fifteen (15) days of service of this Summary Order, may file with the Kansas Insurance Department a written request for hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to:

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.


