**SUMMARY ORDER**  
(Pursuant to K.S.A. 40-4909, K.S.A. 77-501)

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby revokes the agent's license of Respondent, **MICHAEL R. REYNOLDS** ("Respondent"). This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

**Findings of Fact**

The Commissioner finds the following facts:

1. Respondent was licensed as a Kansas resident insurance agent on June 12, 2018 and remains licensed to date.
2. On March 27, 2019, [REDACTED]  
[REDACTED] Respondent received the following conviction:
  - a. March 27, 2019, Johnson County District Court, Case No. 19DV00056, Criminal Damage to Property (Misdemeanor).
    - i. Respondent was sentenced to one year of probation with an underlying jail sentence of sixty days.
    - ii. The Court ordered Respondent to complete a domestic violence assessment as part of the probation.

**Applicable Law**

- Pursuant to K.S.A. 40-4909(a), "The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
  - (6) Been convicted of a misdemeanor or felony." K.S.A. 40-4909(a)
- Pursuant to K.S.A. 40-4909(b), "In addition, the commissioner may suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the interests of the insurer or the insurable interests of the public are not properly served under such license." K.S.A. 40-4909(b)

**Policy Reasons**

1. It is in the public interest that the license of an agent who has recently been convicted of a misdemeanor involving damage to property be revoked.

**Conclusions of Law**

1. The Commissioner has jurisdiction over **MICHAEL R. REYNOLDS** as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
2. The Commissioner finds that Respondent's Kansas license may be revoked because **MICHAEL R. REYNOLDS** was recently convicted of a misdemeanor involving damage to the property of another.
3. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent's license.
4. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of **MICHAEL R. REYNOLDS**, pursuant to K.S.A. 40-4909(a) and (b).

**IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:**


1. The Kansas resident Insurance Agent's License of **MICHAEL R. REYNOLDS** is hereby **REVOKED** the effective date of this Order.
2. **IT IS FURTHER ORDERED** that **MICHAEL R. REYNOLDS** shall **CEASE** and **DESIST** from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

**MICHAEL R. REYNOLDS**, within fifteen (15) days of service of this Summary Order, may file with the Kansas Insurance Department a written request for hearing on this Summary Order, as provided by K.S.A. 77-542. In the event a hearing is requested, such request should be directed to:

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
