SUMMARY ORDER

(Pursuant to K.S.A. 40-4909, K.S.A. 77-501)

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby revokes the agent's license of Respondent, **SHENIE SHEHARA WIJESURENDRA** ("Respondent"). This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

Findings of Fact

The Commissioner finds the following facts:

- 1. Respondent was licensed as a Kansas resident insurance agent on August 6, 2018, and remains licensed to date.
- 2. Respondent's legal (residential) address of record is , Wichita KS
- 3. On August 6, 2018 was granted an insurance agent license by the Kansas Insurance Department ("KID").
- 4. KID found the following:
 - a. Respondent is in the United States on a F1 Student Visa and is officially a citizen of Sri Lanka.
 - b. Respondent attended college at Wichita State University and was eligible to work in off-campus employment under the Curricular Practical Training option of the F1 visa.
 - c. Respondent worked for Northwest Mutual as a licensed agent.
 - d. As part of the requirements to comply with the F1 visa, Respondent was required to show documentation to prove continued eligibility to work by her school and employer.
- 5. Respondent agreed to show proof of her continued eligibility under the F1 student visa by submitting an approval form from her Designated School Official and a letter from her employer. This was to be done by February 1st and September 1st of each semester that she participated in the program and as a licensed agent. Respondent was advised that failure to submit the proof could cause KID to take action against her license.
- 6. KID confirmed that Respondent's appointment with Northwestern Mutual was canceled on November 1, 2018. A staff member with Respondent's Northwestern Mutual office advised Respondent was not meeting internal goals as a producer.
- As of today's date, KID has not received any documentation from Respondent confirming her continued eligibility and Respondent has not returned email or phone messages from KID staff.

Applicable Law

- Pursuant to K.S.A. 40-4909(a), "The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
 - o (8) Used any fraudulent, coercive, or dishonest practice, or demonstrated any incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere." K.S.A. 40-4909(a)

Policy Reasons

- 1. It is in the public interest that the license of an agent who failed to submit required documentation to the Commissioner be revoked.
- 2. It is in the public interest that the license of an agent who does not respond to valid inquiries from the Commissioner be revoked.

Conclusions of Law

- 1. The Commissioner has jurisdiction over **SHENIE SHEHARA WIJESURENDRA** as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 2. The Commissioner finds that Respondent's Kansas license may be revoked because **SHENIE SHEHARA WIJESURENDRA** demonstrated untrustworthiness in the conduct of business in Kansas.
- 3. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent's license.
- 4. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent's license of **SHENIE SHEHARA WIJESURENDRA**, pursuant to K.S.A. 40-4909(a) and (b).

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

- 1. The Kansas Resident Insurance Agent's License of SHENIE SHEHARA WIJESURENDRA is hereby REVOKED the effective date of this Order.
- 2. IT IS FURTHER ORDERED that SHENIE SHEHARA WIJESURENDRA shall CEASE and DESIST from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
