SUMMARY ORDER

(Pursuant to K.S.A. 40-4909, K.A.R. 40-7-9, K.S.A. 77-501, *et seq.*)

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") by K.S.A. 40-4909, the Commissioner hereby revokes the insurance agent's license of Respondent, **KYLOR KEITH FIELD** ("Respondent"). This Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period if no request for hearing is made, pursuant to K.S.A. 77-542.

Findings of Fact

The Commissioner finds the following facts:

1. Respondent was licensed as a Kansas resident insurance agent on September 11, 2018, and remains licensed to date.
2. Respondent's legal (residential) address of record is [REDACTED] [REDACTED] [REDACTED] Kansas City, KS [REDACTED]-[REDACTED]
3. The Kansas Insurance Department ("Department") received a criminal history report on or about September 19, 2019, stating that Respondent was convicted of Possession of hallucinogenic drug (Misdemeanor) and Use/possess with intent to use drug paraphernalia into human body (Misdemeanor) in Merriam Municipal Court on September 12, 2019 (Case No. E023228).
4. The Department sent a letter to Respondent on January 22, 2020 to his mailing address inquiring about the matter.
5. Respondent, to this date, has not notified the Department of the conviction.

Applicable Law

- Pursuant to K.S.A. 40-4909(a), "The commissioner may deny, suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the applicant or license holder has:
 - (2) Violated:
 - (A) Any provision of chapter 40 of the Kansas Statutes Annotated, and amendments thereto, or any rule and regulation promulgated thereunder; and
 - (6) Been convicted of a misdemeanor or felony."
- Pursuant to K.S.A. 40-4909(b), "In addition, the commissioner may suspend, revoke or refuse renewal of any license issued under this act if the commissioner finds that the

interests of the insurer or the insurable interests of the public are not properly served under such license.”

- Pursuant to K.A.R. 40-7-9, “Agents; change in the information contained on the most recent application for a license. Each person licensed in this state as an insurance agent shall report the following to the commissioner of insurance within 30 days of occurrence:
 - (d) all details of any conviction of a misdemeanor or felony. The details shall include the name of the arresting agency, the location and date of the arrest, the nature of the charge or charges, the court in which the case was tried, and the disposition rendered by the court. Minor traffic violations may be omitted.”

Policy Reasons

1. It is in the public interest that the license of an agent who failed to notify the Department of a misdemeanor conviction and failed to respond to an inquiry about the conviction, as required by an insurance regulation, be revoked.

Conclusions of Law

1. The Commissioner has jurisdiction over **KYLOR KEITH FIELD** as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
2. The Commissioner finds that Respondent’s Kansas license may be revoked because **KYLOR KEITH FIELD** was recently convicted of a misdemeanor.
3. The Commissioner finds that Respondent’s Kansas license may be revoked because **KYLOR KEITH FIELD** failed to notify the Commissioner of his recent criminal conviction.
4. The Commissioner finds, pursuant to K.S.A. 40-4909(b), that the interests of the public are not properly served under Respondent’s license.
5. Accordingly, the Commissioner concludes that sufficient grounds exist for the revocation of the insurance agent’s license of **KYLOR KEITH FIELD**, pursuant to K.S.A. 40-4909(a) and (b).

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

1. The Kansas resident Insurance Agent’s License of **KYLOR KEITH FIELD** is hereby **REVOKED** the effective date of this Order.
2. **IT IS FURTHER ORDERED** that **KYLOR KEITH FIELD** shall **CEASE** and **DESIST** from the sale, solicitation or negotiation of insurance and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance conducted after the effective date of this Order.

NOTICE AND OPPORTUNITY FOR HEARING

Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(f). Costs shall include witness fees, mileage allowances, any costs associated with reproduction of documents which become part of the hearing record, and the expense of making a record of the hearing.

If a hearing is not requested, this Summary Order shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
