ORDER DENYING REQUEST FOR A HEARING (Pursuant to K.S.A. 40-4906 and K.S.A. 77-501 et seq.)

The Kansas Insurance Department ("Department") denied the application of Charmaine Shine ("Applicant") for a Kansas nonresident insurance producer's license ("Application") by a Decision on License Application ("Denial Letter") dated December 29, 2022. Applicant submitted a request for a hearing after the deadline to request the hearing expired.

The Commissioner finds that the evidence establishes the Applicant's request for a hearing was untimely and therefore denies the Applicant's request.

Findings of Fact

- 1. Applicant's Application was denied by a Denial Letter dated December 29, 2022.
- 2. Applicant was notified in the Denial Letter as follows:

You have a right to a hearing before the Assistant Commissioner of Insurance to appeal the staff decision to deny your application for a license. Pursuant to K.S.A. 77-537 and K.S.A. 77-542, within fifteen (15) days (with an additional three (3) days for service) of the date of this letter, you may submit a written request for an appeal. A form which you may use for this purpose is enclosed. [Emphasis added.]

- 3. Applicant's deadline to submit a request for a hearing expired on January 17, 2023.
- 4. The Denial Letter further notified Applicant that in the absence of a request for a hearing, "in the time and manner stated" [Emphasis added], the denial would become effective as a Final Order.
- 5. Applicant submitted a request for a hearing, via electronic mail on January 19, 2023.

Applicable Law

- 6. The Commissioner has jurisdiction over the Applicant as well as the subject matter of this proceeding, and such proceeding is held in the public interest.
- 7. Pursuant to K.S.A. 77-526(a), the Assistant Commissioner of Insurance acting on behalf of the Commissioner of Insurance as the agency head, as provided in K.S.A. 77-547, is empowered to render a Final Order.
- 8. Pursuant to K.S.A. 40-4905(g), "Any applicant whose application for a license is denied shall be given an opportunity for a hearing in accordance with the provisions of the Kansas administrative procedure act ["KAPA"]."
- 9. Under KAPA, "Any notice of agency action resulting in a right to request a hearing pursuant to the Kansas administrative procedure act must include a statement informing the person that a written request for a hearing must be file with the agency within 15 days of service of the notice." K.S.A. 77-542(a).
- 10. Pursuant to K.S.A. 77-537(b)(2), "The state agency shall serve each party with a copy of the order in a summary proceeding in the manner prescribed by K.S.A. 77-531, and amendments thereto. The order shall include...notice of the time and manner for requesting a hearing on the order, as provided in K.S.A. 77-542."
- 11. Pursuant to K.S.A. 77-531(b), when a party has the right to request a hearing within a prescribed period of time after service of the notice and the notice is sent by mail or electronic means, three days shall be added to the prescribed period.
- 12. Pursuant to K.S.A. 77-537(b)(3), a summary order served on a party shall include "notice that, if a hearing is not requested, the order shall become effective upon the expiration of the time for requesting a hearing." [Emphasis added.]

Findings of Fact and Conclusions of Law

- 13. The Assistant Commissioner of Insurance, as the Presiding Officer, is acting on behalf of the Commissioner of Insurance as the agency head and is empowered to render a Final Order.
- 14. Applicant was notified by the Denial Letter dated December 29, 2022, that she had fifteen (15) days (with an additional three (3) days for service) to request a hearing to appeal the decision to deny her license application. Applicant was further notified by the letter that failure to appeal the decision would result in the letter becoming effective as a final order.
- 15. The Presiding Officer finds that the notice of the time and manner in which to request a hearing on the summary order denying the Applicant's license application provided by Department to the Applicant met the requirements of KAPA.
- 16. The Presiding Officer finds the hearing request submitted by Applicant on January 19, 2023, was untimely.
- 17. The Decision on License Application denying the Applicant's application for licensure became a Final Order when the Applicant did not request a hearing within the time specified in the notification included in the Denial Letter.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT Applicant submitted an untimely request for a hearing. The untimely request for a hearing is **DENIED**. The contents of the December 29, 2022, letter describing the Department's reasons for the denial became a **Final Order as a matter of law** when Applicant failed to timely request an administrative hearing.
