ORDER OF REVOCATION ADMINISTRATIVE ACTION

This is to notify you that your Kansas nonresident insurance producer license is **REVOKED** due to the suspension of your resident insurance producer license in your home state of Florida on or about November 14, 2024.

K.S.A. 40-4909(a)(2)(A) grants the Commissioner of Insurance ("Commissioner") authority to revoke your insurance producer's license if you have violated any provision of chapter 40 of the Kansas Statutes Annotated. K.S.A. 40-4906 requires a nonresident insurance agent to be currently licensed and in good standing as a resident insurance agent in the person's home state. In addition, K.S.A. 40-4909(a)(9) allows the Commissioner to revoke an insurance producer license if it is found that the license holder has had an insurance agent license, or its equivalent, denied, suspended or revoked in any state, district or territory. Since you no longer hold a license in your home state as it has been suspended, your Kansas Nonresident Insurance Producer License is hereby revoked.

This revocation constitutes an administrative action which you will be required to disclose on all future licensing applications. You may also be required to report this administrative action to any other state where you are currently licensed, in accordance with the requirements of each state.

IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:

- 1. Pursuant to K.S.A. 40-4909, the Kansas Nonresident license of **MATTHEW VEGA-SANZ** is hereby REVOKED.
- 2. IT IS FURTHER ORDERED that MATTHEW VEGA-SANZ shall CEASE and DESIST from the sale, solicitation or negotiation of insurance in Kansas and/or receiving compensation deriving from the sale, solicitation or negotiation of insurance in Kansas conducted after the effective date of this Order.

If you request a hearing, the Kansas Department of Insurance will serve notice of the time and place of the hearing and information on procedures, right of representation, and other rights of parties relating to the conduct of the hearing. Any costs incurred as a result of conducting any administrative hearing shall be assessed against the agent/agency who is the subject of the hearing as provided by K.S.A. 40-4909(g).

If a hearing is not requested, this letter shall become effective as a Final Order, without further notice, upon the expiration of the fifteen (15) day period for requesting a hearing. The Final Order will constitute final agency action in the matter.
