**CONSENT ORDER**

Tressa V. Poley-Bolze ("Poley-Bolze") wishes to resolve this matter without formal adjudicative proceedings by entering into this consent order. The Commissioner of Insurance ("Commissioner") hereby makes the following findings of fact, conclusions of law, and order, to-wit:

**Findings of Fact**

1. Records maintained by the Kansas Insurance Department ("KID") indicate that Poley-Bolze is a resident of the State of Kansas, has a current mailing address of 8235 S.W. 10<sup>th</sup> Street, Topeka, Kansas 66615, and filed an application for a Kansas resident insurance agent's license which was denied.
2. The Commissioner has jurisdiction over the subject matter of this proceeding, and this proceeding is held in the public interest.
3. On January 6, 1999, KID received Poley-Bolze's application and materials for a Kansas resident insurance agent's license.
4. Information submitted to KID and it's subsequent investigation indicated that on several occasions, action requesting judgment had been filed against Poley-Bolze against her in Shawnee County District Court.

5. On January 12, 1999, KID sent a letter to Poley-Bolze informing her that in view of the actions requesting judgment filed against her, she had failed to establish that she was of good business reputation and worthy of a license and her application for an agents license was denied.

6. On January 19, 1999, KID received a letter from Poley-Bolze requesting a hearing.

7. In addition to Poley-Bolze's request for a hearing were eleven (11) letters of recommendation from the following: Clayton D. Parker, Partner of Triple T's; Ben Meek, President of the First National Bank in St. Mary's, Kansas; Larry K. Rogers, President of the Fremont County Saving Bank in Sidney, Iowa; Lynn L. Schoonover of the Kansas State Bank in Overbrook, Kansas; Don Cooper, CEO and Senior Adjuster of Cooper Claims Service, Inc. in Topeka, Kansas; Steven R. Wiechman, Attorney at Law in Topeka, Kansas; Margaret L. Bacon of Topeka, Kansas; Donald J. Hock, President of Kansas Fly Ash, Inc. in Rifle, Colorado; Harold R. King, Ph.D. of Essex, Iowa; Robert D. Gregory of The Villages, Inc. in Topeka, Kansas; and Beverly C. Evans, LSCSW, of Associates in Clinical & Community Services in Topeka, Kansas .

8. On February 3, 1999, KID received a letter from Richard Snavely, District Manager of Combined Insurance Company of America ("Combined") indicating that Poley-Bolze would be working at Combined once she received her license. Additionally, he would be her District Manager and Poley-Bolze would be reporting to Larry Wiecken.

### **Conclusions of Law**

9. K.S.A. 1997 Supp. 40-240 provides, in relevant part:

- (a) Any person desiring as agent to engage in the insurance business...shall establish:...

(2) that the applicant is of good business reputation and is worthy of a license.

10. Based upon the information contained in paragraphs 4 through 5 above, it appears that sufficient evidence exists for the denial of Tressa V. Poley-Bolze's application for an insurance agent's license pursuant to K.S.A. 1997 Supp. 40-240, in accordance with the procedures set forth in the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., as amended.

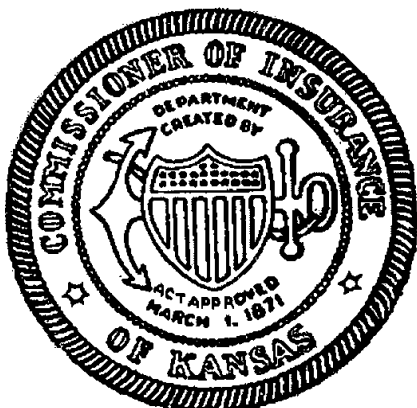
11. Tressa V. Poley-Bolze admits to the allegations set forth herein this order as described above.

12. For the purposes of this Consent Order, Tressa V. Poley-Bolze waives the right to a formal adjudicative proceeding and notice thereof and voluntarily consents to the following order of the Commissioner of Insurance.

**IT IS THEREFORE ORDERED BY THE COMMISSIONER OF INSURANCE THAT:**

1. Due to the eleven (11) letters of recommendation and the letter of employment from Combined, Tressa V. Poley-Bolze will be issued a Kansas resident insurance agent's license upon the receipt of this signed Consent Order.
