The above-captioned matter comes before the Securities Commissioner of the State of Kansas (“Commissioner”) on consideration of the *Joint Motion to Vacate Order to Cease and Desist and to Dismiss* (“Joint Motion”), filed herein on August 8, 2018.

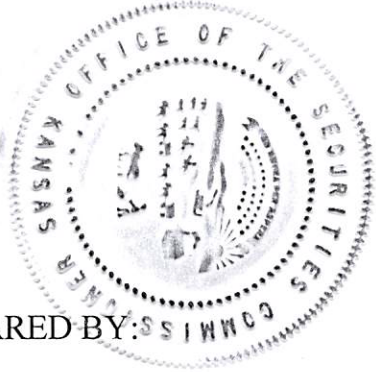
WHEREUPON, after fully considering the pleadings filed herein and being otherwise duly advised in the premises, the Commissioner finds that the Joint Motion should be granted. The relief granted in the *Consent Judgment and Permanent Injunction* entered by the Court on August 8, 2018, in *Office of the Kansas Securities Commissioner ex rel. John R. Wine, Jr. v. Harris Custom Projects, LLC, et al.*, Case No. 2018-CV-001287-OT (18th Jud. Dist. Ct., Sedgwick Cty.) makes this administrative action duplicative and unnecessary. The Order to Cease and Desist issued on February 19, 2018, is hereby vacated, and administrative action docketed as number 18E050 is hereby dismissed with prejudice.

IT IS THEREFORE ORDERED that the *Order to Cease and Desist* issued herein on February 19, 2018, is VACATED; and

IT IS FURTHER ORDERED that the administrative action docketed as number 18E050 is DISMISSED with prejudice
