Dear Sir or Madam,

Under K.S.A. 40-952(c), title insurance agents and agencies are required to file every manual of classification, rules and rates, every rating plan, every rate card and every modification of the foregoing which may be used in connection with providing title insurance or other services in connection with real estate transactions on property located in counties having a population of 10,000 or more.

The Kansas Insurance Department ("Department") is auditing title agency files and our records indicate that we do not have any title insurance rates on file for your agency.

In order to be exempt from this requirement, you must provide a letter confirming you are only providing title insurance for properties located in counties with populations under 10,000.

Within 15 days of the date of this letter, you must either (1) submit a letter stating you are exempt from filing rates, or (2) submit the rates used by your agency electronically via email to kid.addpc@ks.gov with "Title" in the subject line of the email. If your agency is utilizing the rates and charges filed with the Department by the underwriting insurance companies with which you work, your agency must file the underwriters' rates and charges as your own.

Failure to file your title insurance rates (or letter indicating you only provide title insurance on properties in counties with population under 10,000) will result in administrative action against your license. If you are no longer acting as a title agency in Kansas, please immediately advise the Department of such via email to kid.addpc@ks.gov with "Title" in the subject line of the email.

If you have previously sent this information to the Department, we apologize that we are unable to locate it in the Department's records. However, we appreciate your prompt attention in assisting

the Department to verify that your agency is meeting its statutory requirements to serve as a title agency in Kansas.
