**ORDER ON LIQUIDATOR’S MOTION FOR APPROVAL OF  
FEES AND TO DISCONTINUE PROVIDING LOSS RUNS,  
CLAIM HISTORY REPORTS, AND CREDENTIALS**

THIS MATTER is before the Court on the Motion for Approval of Fees and to Discontinue Providing Loss Runs, Claim History Reports, and Credentials (the “Motion”) filed by Vicki Schmidt, the Kansas Commissioner of Insurance (“Commissioner”), in her capacity as the liquidator (“Liquidator”) of Physicians Standard Insurance Company (“PSIC”) filed on March 30, 2021. The Liquidator has communicated with the Missouri Insurance Guaranty Association and the Kansas Insurance Guaranty Association regarding the Motion, and they have no objections. No objections to the Motion have been filed and the Motion is now ripe for ruling. The Court having reviewed the pleadings hereby ORDERS that:

1. The Motion is GRANTED as set forth herein.
2. To preserve the assets of the estate, the Liquidator shall discontinue providing loss runs, claims history reports, or credentialing verification reports to former PSIC insureds, effective April 15, 2021.
